RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE;
CREATING A COMMISSION TO CELEBRATE THE FOUR HUNDREDTH
ANNIVERSARY OF THE FIRST SPANISH COLONY AT SAN GABRIEL AT SAN
JUAN PUEBLO; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. COMMISSION--APPOINTMENT AND TERMS--DUTIES.--

A. There is created the "San Gabriel commission", to be composed of seven members, three members appointed by the speaker of the house of representatives, three members appointed by the president pro tempore of the senate and one member appointed by the governor. Members shall serve from the time of their appointment until January 1, 1999. Each member of the commission shall be a resident of north-central New Mexico. The commission shall select a chairperson and such other officers it deems appropriate from among its membership. Commission members

shall receive no salary, per diem, mileage or other compensation or perquisite.

B. The San Gabriel commission shall recommend to the office of cultural affairs a suitable permanent artistic monument or display commemorating the first settlement by Hispanic people north of the Rio Grande at San Gabriel de Yunque Yunque, now known as San Juan pueblo, in Rio Arriba county. The commission shall, with the assistance of the Hispanic cultural division of the office of cultural affairs, arrange a suitable celebration marking this historic event and shall seek funding for the celebration from public and private sources.

Section 2. APPROPRIATION. --Two hundred twenty-five thousand dollars (\$225,000) is appropriated from the general fund to the Hispanic cultural division of the office of cultural affairs for expenditure in fiscal years 1996 and 1997 to acquire and install, at the municipal plaza in the city of Espanola in Rio Arriba county, a permanent artistic monument or display commemorating the first Hispanic settlement north of the Rio Grande at San Gabriel de Yunque Yunque. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 3. EMERGENCY. --It is necessary for the public peace, health and safety that this act take effect immediately.
