FOR THE LEGISLATIVE HEALTH AND HUMAN SERVICES COMMITTEE

MAKING AN APPROPRIATION TO THE HUMAN SERVICES DEPARTMENT TO PROVIDE OR CONTRACT FOR SERVICES AND PROGRAMS FOR NEW MEXICO'S HOMELESS PEOPLE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three million dollars (\$3,000,000) is appropriated from the general fund to the human services department for expenditure in fiscal year 1997 to provide or contract for community-based programs and services that provide homeless people with a continuum of care, including housing and shelter, income, training and jobs, and health and social services. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
