AN ACT

MAKING AN APPROPRIATION TO PROVIDE FOR ECONOMIC DEVELOPMENT
INITIATIVES AND FOR ASSISTANCE TO SMALL BUSINESSES, MINORITY-OWNED
BUSINESSES AND WOMEN-OWNED BUSINESSES IN NORTHERN NEW MEXICO;
DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Two hundred fifty thousand dollars (\$250,000) is appropriated from the general fund to the economic development department for expenditure in fiscal years 1996 and 1997 for the purpose of contracting for services to provide for economic development initiatives and for assistance to small businesses, minority-owned businesses and women-owned businesses in northern New Mexico. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
