Section 1. APPROPRIATION. -- Two hundred thousand dollars (\$200,000) is appropriated from the general fund to the department of public safety for expenditure in fiscal year 1997 to enhance a forsenic interview program for allegedly sexually abused children to ensure the availability of these services on a statewide basis. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
