AN ACT

MAKING APPROPRIATIONS TO PROVIDE OR CONTRACT FOR STATEWIDE SAFE
WATER AND OTHER PROGRAMS FOR INDIGENT NEW MEXICANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. Two million dollars (\$2,000,000) is appropriated
from the general fund to the human services department for
expenditure in fiscal year 1997 in the following amounts for the
following purposes:

(1) one million dollars (\$1,000,000) to provide
or contract for statewide safe water programs and services for
indigent New Mexicans; and

(2) one million dollars (\$1,000,000) to provide
or contract for statewide community supplemental block grant
