AN ACT

MAKING AN APPROPRIATION FOR AN EXPANDED EMERGENCY MEDICAL SERVICES PROGRAM; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred ninety thousand dollars (\$190,000) is appropriated from the general fund to the primary care and emergency medical services bureau of the public health division of the department of health for expenditure in fiscal years 1996, 1997 and 1998 for the purpose of developing expanded emergency medical services training programs and components and implementing additional expanded emergency medical services models in certain high priority medically underserved areas of the state. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
