AN ACT

RELATING TO CAPITAL EXPENDITURES; MAKING APPROPRIATIONS TO
PURCHASE EQUIPMENT AND COMPUTER SOFTWARE FOR THE MINERS' COLFAX
MEDICAL CENTER LOCATED IN COLFAX COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS--MINERS' TRUST FUND--PURPOSE.--

A. The following amounts are appropriated from the
miners' trust fund to the miners' Colfax medical center located
in Colfax county for expenditure in fiscal years 1996 through
2000 for the following purposes:

- (1) thirty-nine thousand dollars (\$39,000) to
purchase a blood gas oximetry unit;
- (2) thirty-three thousand dollars (\$33,000) to
purchase bath tubs for the long-term care facility;
- (3) two hundred twenty-five thousand dollars

- 1 (\$225,000) to purchase an ultrasound machine;
- 2 (4) forty-eight thousand dollars (\$48,000) to
- 3 purchase a phacoemulsification unit;

- 5 (\$65,100) to purchase electric beds for the long-term care
- 6 facility;
- 7 (6) thirty-three thousand dollars (\$33,000) to
- 8 purchase order entry software;
- 9 (7) thirty thousand dollars (\$30,000) to
- 10 purchase an x-ray film storage unit;
- 11 (8) one hundred twelve thousand seven hundred
- 12 dollars (\$112,700) to purchase optical disk software and
- 13 hardware;
- 14 (9) thirty-two thousand dollars (\$32,000) to
- 15 purchase an ultrasound machine to be used in the obstetric
- 16 department; and
- 17 (10) one hundred seventeen thousand dollars
- 18 (\$117,000) to purchase a nursing information computer system.

19 B. Any unexpended or unencumbered balance remaining

20 at the end of fiscal year 2000 shall revert to the miners' trust

21 fund.

22 Section 2. EMERGENCY.--It is necessary for the public

23 peace, health and safety that this act take effect immediately.
