AN ACT

MAKING AN APPROPRIATION FOR A PUBLIC SERVICE PARTNERSHIP
INITIATIVE TO ESTABLISH A PARTNERSHIP BETWEEN AREA COLLEGES AND
UNIVERSITIES AND LOCAL COMMUNITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three hundred thousand dollars
(\$300,000) is appropriated from the general fund to the
commission on higher education for expenditure in fiscal year
1997 for the purpose of organizing and selecting participants
for a public service partnership initiative. In organizing the
initiative, the commission on higher education shall provide for
the selection of participants and the distribution of awards to
selected participating colleges and universities in an amount
not to exceed fifty thousand dollars (\$50,000) per award.
Awards shall be expended by the participating educational

1 institution to form a partnership with a local community service
2 provider. The partnership developed shall use educational
3 institution resources to address issues and concerns in the
4 local community. Any unexpended or unencumbered balance
5 remaining at the end of fiscal year 1997 shall revert to the
