1 upon a finding by the board that the project has been developed sufficiently to justify the issuance and that the project can 2 proceed to contract within a reasonable time. The state board 3 of finance shall further take the appropriate steps necessary to 4 comply with the Internal Revenue Code of 1986, as amended. 5 The 6 proceeds from the sale of the bonds are appropriated to the department of environment for the purpose of planning, designing 7 or constructing an administrative office facility for the 8 9 Anthony water and sanitation district located in Dona Ana 10 Any unexpended or unencumbered balance remaining at the county. 11 end of fiscal year 1999 shall revert to the severance tax 12 bonding fund. If the department of environment has not 13 certified the need for the issuance of the bonds by the end of 14 fiscal year 1998, the authorization provided in this section 15 shall be void.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
