MAKING AN APPROPRIATION TO THE UNIVERSITY OF NEW MEXICO FOR A
YOUTH DEVELOPMENT PROGRAM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Ninety-nine thousand dollars
(\$99,000) is appropriated from the general fund to the board of
regents of the university of New Mexico for expenditure in
fiscal year 1997 for a youth program that teaches high school
students leadership skills and encourages their enrollment in
college. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1997 shall revert to the general fund.
