AN ACT

MAKING AN APPROPRIATION FOR A WILDERNESS THERAPY PROGRAM FOR
MENTALLY ILL PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars
(\$100,000) is appropriated from the general fund to the mental
health division of the department of health for expenditure in
fiscal year 1997 for the purpose of contracting for a wilderness
therapy program for adults with chronic mental illness that
integrates challenging wilderness activities with counseling
techniques to build self-esteem, foster independence and develop
skills with which to cope with their illness. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997
shall revert to the general fund.
