MAKING AN APPROPRIATION FOR THE NAVAJO NATION CHILD SUPPORT ENFORCEMENT PROGRAM IN SAN JUAN AND MCKINLEY COUNTIES; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the human services department for expenditure in fiscal years 1996 and 1997 for the purpose of contracting with the Navajo nation to provide child support enforcement services to citizens living within the boundaries of the Navajo nation in San Juan and McKinley counties. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public
