AN ACT

MAKING AN APPROPRIATION FOR OPERATING COSTS, HIRING AN OCCUPATIONAL THERAPY COORDINATOR AND PURCHASING NECESSARY LEARNING RESOURCES FOR THE SCHOOL OF OCCUPATIONAL THERAPY AT THE UNIVERSITY OF NEW MEXICO IN ALBUQUERQUE LOCATED IN BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Seventy-three thousand dollars (\$73,000) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal years 1996 and 1997 for the purpose of funding operating costs, hiring an occupational therapy coordinator and purchasing necessary learning resources for the school of occupational therapy at the university of New Mexico in Albuquerque located in Bernalillo county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
