AN ACT

MAKING AN APPROPRIATION TO THE UNIVERSITY OF NEW MEXICO FOR THE  
ELECTRONIC DISSEMINATION VIA THE INTERNET OF INFORMATION RELEVANT  
TO LATIN AMERICAN ECONOMIC DEVELOPMENT; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Fifty thousand dollars (\$50,000) is appropriated from  
the general fund to the board of regents of the university of New Mexico for expenditure in  
fiscal years 1996 and 1997 for the purpose of funding the  
Ibero-American science and technology education consortium to electronically disseminate via  
the internet information relevant to Latin American economic development. Any unexpended  
or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general  
fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that  
this act take effect immediately.
