AN ACT

MAKING AN APPROPRIATION TO PROVIDE COURT SERVICES IN GRANT, LUNA  
AND HIDALGO COUNTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Sixty thousand dollars (\$60,000) is appropriated  
from the general fund to the sixth judicial district for  
expenditure in fiscal year 1997. The appropriation shall be  
spent in the following manner:

(1) fifty-five thousand dollars (\$55,000) to  
contract for a special master to hear matters requiring  
expedited hearing in Grant, Luna and Hidalgo counties; and

(2) five thousand dollars (\$5,000) for the  
court-appointed special advocate program.

B. Any unexpended or unencumbered balance remaining
