MAKING AN APPROPRIATION FOR A STUDY ON NECESSARY UPGRADES AND  
RENOVATIONS AND ASSOCIATED COSTS FOR THE CRYSTAL IRRIGATION  
SYSTEM IN SAN JUAN COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Eighty-six thousand dollars  
(\$86,000) is appropriated from the general fund to the New  
Mexico office of Indian affairs for expenditure in fiscal year  
1997 to fund and conduct a study to determine necessary upgrades  
and renovations to and associated costs for such upgrades and  
renovations for the Crystal irrigation system in the Navajo  
nation in San Juan county. Any unexpended or unencumbered  
balance remaining at the end of fiscal year 1997 shall revert to  
the general fund.

APPROPRIATION. --Forty thousand dollars (\$40,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal year 1997 for the purpose of purchasing a bus for the headstart program at Cochiti pueblo in Sandoval county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 3. APPROPRIATION. --Twenty thousand dollars (\$20,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal year 1997 to equip and upgrade recreational facilities at Cochiti pueblo in Sandoval county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.",  
and thence referred to the FINANCE COMMITTEE.
