AN ACT

MAKING APPROPRIATIONS FOR CERTAIN SENIOR CITIZEN PROGRAMS
THROUGHOUT THE STATE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. The following amounts are appropriated from the
general fund to the state agency on aging for expenditure in
fiscal year 1997 for the following purposes:

(1) one hundred seventy-seven thousand dollars
(\$177,000) to fund foster grandparent programs throughout the
state;

(2) two hundred forty thousand dollars
(\$240,000) to fund retired and senior companion programs
throughout the state; and

(3) sixty thousand dollars (\$60,000) to fund
