- (1) one million dollars (\$1,000,000) to provide or contract for domestic violence prevention programs and services for adults;
- (2) four hundred thousand dollars (\$400,000) to provide or contract for expanded home care programs or services for adults;
  - (3) four hundred thousand dollars (\$400,000) to

provide or contract for expanded attendant care programs and services for adults; and

- В. One million dollars (\$1,000,000) is appropriated from the general fund to the human services department for expenditure in fiscal year 1997 to expand the Medicaid disabled and elderly waiver program and services.
