Section 1. Section 35-1-30 NMSA 1978 (being Laws 1968, Chapter 62, Section 32) is amended to read:

"35-1-30. MAGISTRATE COURT--SIERRA DISTRICT.--There shall be [one magistrate] two magistrates in Sierra magistrate district, with [a] divisions 1 and 2 operating as a single court in Truth or Consequences."

Section 2. TEMPORARY PROVISION--APPOINTMENT AND ELECTION-DIVISION 2.--

district division 2 shall be filled by appointment of the The appointed magistrate shall begin serving January governor. 1, 1997 and shall serve until succeeded by a magistrate elected pursuant to Subsection B of this section.

The first full term of the office of magistrate in Sierra magistrate district division 2 shall be filled by election at the general election in 1998, and that term of office shall begin on January 1, 1999.

Section 3. APPROPRIATION. -- Thirty-five thousand dollars (\$35,000) is appropriated from the general fund to the administrative office of the courts for expenditure in fiscal year 1997 for salary, benefits, office space and supplies for one new magistrate judge in Sierra magistrate district division 2. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
