

	RELATING TO CAPITAL EXPENDITURES; AUTHORIZING THE ISSUANCE OF
12	SEVERANCE TAX BONDS TO DESIGN, CONSTRUCT AND EQUIP A NEW BECENTI

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. SEVERANCE TAX BONDSPURPOSE FOR WHICH ISSUED
18	APPROPRIATION OF PROCEEDSThe state board of finance may issue and sell severance
19	tax bonds in compliance with the Severance Tax Bonding Act in an amount not exceeding two
20 21	hundred fifty thousand dollars (\$250,000) when the New Mexico office of Indian affairs
21 22	certifies the need for the issuance of the bonds. The state board of finance shall schedule the
22	issuance and sale of the bonds in the most expeditious and economical manner possible upon a
23	finding by the board that the project has been developed sufficiently to justify the issuance and
25	that the project can proceed to contract within a reasonable time. The state board of finance
	shall further take the appropriate steps necessary to comply with the Internal Revenue Code of
	1986, as amended. The proceeds from the sale of the bonds are appropriated to the New
	Mexico office of Indian affairs for the purpose of designing, constructing and equipping a new


1	Becenti senior center located in McKinley county. Any unexpended or unencumbered balance
