17	Section 1. SEVERANCE TAX BONDSPURPOSE FOR WHICH ISSUED
18	APPROPRIATION OF PROCEEDSThe state board of finance may issue
19	and sell severance tax bonds in compliance with the Severance
20	Tax Bonding Act in an amount not exceeding one million eight
21	hundred sixty thousand dollars (\$1,860,000) when the local
22	government division of the department of finance and
23	administration certifies the need for the issuance of the bonds.
24	The state board of finance shall schedule the issuance and sale
25	of the bonds in the most expeditious and economical manner

1 possible upon a finding by the board that the project has been developed sufficiently to justify the issuance and that the 2 project can proceed to contract within a reasonable time. 3 The state board of finance shall further take the appropriate steps 4 necessary to comply with the Internal Revenue Code of 1986, as 5 6 amended. The proceeds from the sale of the bonds are 7 appropriated to the local government division of the department of finance and administration for the purpose of land 8 9 reclamation and to plan, design and construct an inner city park 10 for Santa Fe located in Santa Fe county. Any unexpended or 11 unencumbered balance remaining at the end of fiscal year 1999 12 shall revert to the severance tax bonding fund. If the local 13 government division of the department of finance and 14 administration has not certified the need for the issuance of the bonds by the end of fiscal year 1998, the authorization 15 16 provided in this section shall be void.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
