AN ACT

RELATING TO CAPITAL EXPENDITURES; REAUTHORIZING UNEXPENDED OR UNENCUMBERED BALANCES; CHANGING THE PURPOSE OF A SEVERANCE TAX BOND AUTHORIZATION FOR THE PLACITAS COMMUNITY CENTER LOCATED IN DONA ANA COUNTY; EXTENDING THE PERIOD OF EXPENDITURE; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. SEVERANCE TAX BONDS--DEPARTMENT OF FINANCE AND ADMINISTRATION--CHANGE IN PURPOSE--APPROPRIATION.--The balance of the proceeds from severance tax bonds appropriated to the local government division of the department of finance and administration for adding a recreation room to the Placitas community center located in Dona Ana county, pursuant to Subsection YYYY of Section 9 of Chapter 148 of Laws 1994, shall not be expended for its original purpose but is reauthorized and

appropriated to continue improvements and renovations to the Placitas community center located in Dona Ana county. unexpended or unencumbered balance remaining from the proceeds from the bonds at the end of fiscal year 1999 shall revert to the severance tax bonding fund.

Section 2. EMERGENCY. -- It is necessary for the public peace, health and safety that this act effect immediately.
