AN ACT

MAKING APPROPRIATIONS TO CARRY OUT THE PURPOSES OF THE PRIMARY CARE CAPITAL FUNDING ACT AND THE RURAL PRIMARY HEALTH CARE ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS.--

A. Five million dollars (\$5,000,000) is appropriated from the general fund to the primary care capital fund for expenditure in fiscal year 1997 and subsequent fiscal years to carry out the purposes of the Primary Care Capital Funding Act.

B. Six hundred thousand dollars (\$600,000) is appropriated from the general fund to the department of health for expenditure in fiscal year 1997 to carry out the purposes of the Rural Primary Health Care Act.

C. Any unexpended or unencumbered balance appropriated in Subsection A of this section remaining at the end of any fiscal year shall not revert to the general fund. Any unexpended or unencumbered balance appropriated in Subsection B of this section remaining at the end of fiscal year 1997 shall revert to the general fund.
