AN ACT

MAKING AN APPROPRIATION TO PROVIDE OR CONTRACT FOR CANCER
PATIENT SUPPORT SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars
(\$50,000) is appropriated from the general fund to the
department of health for expenditure in fiscal year 1997 for the
purpose of providing or contracting for comprehensive community-
based cancer patient support services that include education,
one-to-one matching with cancer veterans, survivorship
mentoring, patient library services and an annual conference.
Services shall be available to cancer patients suffering from
any type of cancer. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1997 shall revert to the
general fund.
