Notwithstanding the provisions of Laws 1995, Chapter 218, Section 27, any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the capital program fund.

Section 2. SEVERANCE TAX BONDS--CHANGE IN AGENCY--CONTINUED AUTHORIZATION--CHANGE IN CONTINGENCY--APPROPRIATION.--The balance of the proceeds from severance tax bonds appropriated to the general services department, pursuant to Laws 1992, Chapter 113, Section 20, for the New Day shelter for troubled youth in Albuquerque located in Bernalillo county shall not be expended by that agency nor be subject to the contingency imposed but is reauthorized and appropriated to the local government division of the department of finance and administration and shall be contingent upon the city of Albuquerque receiving a donation from a private or public organization of a minimum of ten acres of land for building the home, and the city of Albuquerque, through its child development office, executing a contract with the private or public
