19	maintaining and expanding a high school education program for
20	at-risk teenage parents, with two hundred eighty thousand
21	dollars (\$280,000) of this appropriation for continuing the
22	basic program and two hundred forty thousand dollars (\$240,000)
23	of this appropriation for expanding the program to four new
24	sites throughout the state and for providing child care at those
