AN ACT

MAKING APPROPRIATIONS TO THE CHILDREN, YOUTH AND FAMILIES
DEPARTMENT AND THE DEPARTMENT OF HEALTH FOR THE PURPOSE OF
PROVIDING OR CONTRACTING FOR VARIOUS SERVICES FOR ADOLESCENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS--CHILDREN, YOUTH AND FAMILIES
DEPARTMENT.--

A. The following amounts are appropriated from the
general fund to the children, youth and families department for
expenditure in fiscal year 1997 for the following purposes:

(1) five hundred thousand dollars (\$500,000)
for mental health in the schools programs;

(2) one million dollars (\$1,000,000) for
independent living programs for youth sixteen to twenty-one
years of age;

(3) one million dollars (\$1,000,000) for
substance abuse prevention programs.

B. Any unexpended or unencumbered balance remaining
at the end of fiscal year 1997 shall revert to the general fund.

Section 2. APPROPRIATION--DEPARTMENT OF HEALTH. --One
million dollars (\$1,000,000) is appropriated from the general
fund to the department of health for expenditure in fiscal year
1997 for the purpose of providing or contracting for substance
abuse treatment programs and services. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997
shall revert to the general fund.
