RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE; MAKING
AN APPROPRIATION FOR THE PURCHASE OF SCHOOL BUSES FOR THE MESA
VISTA HEAD START PROGRAM OPERATING IN TAOS AND RIO ARRIBA
COUNTIES; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred fifty thousand
dollars (\$150,000) is appropriated from the general fund to the
state department of public education for expenditure in fiscal
years 1996 and 1997 for the purpose of purchasing school buses
for the Mesa Vista head start program operating in Taos and Rio
Arriba counties. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1997 shall revert to the
general fund.
