A JOINT MEMORIAL

RECOGNIZING THE RECOMMENDATION OF THE DWI OVERSIGHT TASK FORCE THAT FUNDING FOR THE LOCAL DWI GRANT FUND BE CONTINUED AT A LEVEL CONSISTENT WITH PAST APPROPRIATIONS.

WHEREAS, the local DWI grant fund was created in 1993, as part of the DWI reforms enacted during the 1993 legislative session; and

WHEREAS, grant awards from the local DWI grant fund have been used to finance the operation of community-based programs, services and facilities designed to address the problems of DWI, alcoholism and alcohol abuse; and

WHEREAS, the funding history for the local DWI grant fund is as follows: the 1993 legislature appropriated five million five hundred thousand dollars (\$5,500,000) to the fund; the 1994 legislature appropriated five million dollars

1 (\$5,000,000) to the fund; and the 1995 legislature appropriated  
2 four million nine hundred fifty thousand dollars (\$4,950,000) to  
3 the fund; and

4 WHEREAS, based upon testimony received during the 1995  
5 interim, the DWI Oversight Task Force believes that maintaining  
6 a consistent level of financial support for the local DWI grant  
7 fund will ensure the stability of programs, services and  
8 facilities that address problems caused by DWI, alcoholism and  
9 alcohol abuse in New Mexico's communities;

10 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
11 STATE OF NEW MEXICO that it recognize the recommendation of the  
12 DWI Oversight Task Force that funding for the local DWI grant  
13 fund be continued at a level consistent with past  
14 appropriations; and

15 BE IT FURTHER RESOLVED that copies of this memorial be  
16 transmitted to the chair of the house appropriations and finance  
17 committee, the chair of the senate finance committee and the  
18 secretary of finance and administration.
