A JOINT MEMORIAL
REQUESTING THE CITY OF SANTA FE TO STUDY MEASURES TO RELIEVE

WHEREAS, thousands of citizens come to the capitol
throughout the year, both to see their legislature at work
during the legislative session and to view the capitol; and

WHEREAS, although parking is problematic throughout the
city of Santa Fe, it is severely limited near the capitol,
especially during the legislative sessions; and

WHEREAS, the neighborhood surrounding the Capitol receives
the brunt of the congestion and overcrowding related to parking
during the session and during other times of the year;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
STATE OF NEW MEXICO that the city of Santa Fe be requested to
study alternatives to relieve parking congestion around the
