A JOINT MEMORIAL

REQUESTING THE COMMISSION ON HIGHER EDUCATION TO STUDY THE
POTENTIAL FOR PROVIDING RESIDENT TUITION STATUS TO STUDENTS FROM
STATES WITH RECIPROCAL PROVISIONS.

WHEREAS, the Texas legislature lowered nonresident tuition
for students who reside in a state with a common border with
Texas and reside within one hundred thirty-five miles of the
Texas border; and

WHEREAS, Texas provides for a nonresident to pay resident
tuition if the neighboring state reciprocates; and

WHEREAS, many New Mexico residents live closer to Texas
post-secondary institutions than to New Mexico post-secondary
institutions; and

WHEREAS, New Mexico post-secondary institutions may gain
students from such a provision;
