WHEREAS, no specific program addresses the problems of these individuals; and

WHEREAS, the New Mexico school for the deaf, with its long history of serving the deaf community, has demonstrated a willingness to provide such a program in its well-structured environment; and

WHEREAS, a funding request for such a program was presented to the commission on higher education; and

WHEREAS, with the limited state revenue this year the
