OPPOSING ON BEHALF OF TORRANCE COUNTY, THE CORRECTIONS
DEPARTMENT'S PLAN TO TRANSFER NEW MEXICO PRISONERS TO TEXAS.

WHEREAS, Torrance county entered into a memorandum of
understanding and a joint powers agreement with the corrections
department to incarcerate up to two hundred fifty prisoners; and

WHEREAS, the corrections department has now decided to
ignore that agreement and send the prisoners to Texas for
incarceration; and

WHEREAS, this decision will force Torrance county to lay
off almost one hundred employees resulting in a loss of one
million five hundred thousand dollars (\$1,500,000) to Torrance
county's economy; and

WHEREAS, denying New Mexico citizen taxpayers employment
opportunities and paying New Mexico taxpayers' money to Texas is
