A MEMORIAL

SEEKING TO INVITE THE BASS ANGLERS SPORTSMAN SOCIETY TO CONDUCT
A BASSMASTER INVITATIONAL TOURNAMENT AT ELEPHANT BUTTE
RESERVOIR.

WHEREAS, Elephant Butte reservoir in Sierra county is
widely known as an excellent bass fishery; and

WHEREAS, New Mexico bass fishing clubs regularly hold
successful catch-and-release bass fishing tournaments at
Elephant Butte reservoir; and

WHEREAS, the New Mexico bass federation is affiliated with
the bass anglers sportsman society (B. A. S. S.), the world's
largest fishing organization; and

WHEREAS, the bass anglers sportsman society is interested
in expanding their bassmaster invitational tournament trail
schedule to include a western division; and

1 WHEREAS, B. A. S. S. gains recognition for the sport of bass
2 fishing, fosters a respect for the resource and has become one
3 of the nation's leading publishers and multimedia companies in
4 the outdoor field in that its magazine reaches six million
5 readers and its television program reaches forty-three million
6 households each year; and

7 WHEREAS, bassmaster invitational tournaments benefit host
8 communities by enhancing tourism, creating press and television
9 site exposure, providing immediate positive economic impacts in
10 excess of eight hundred thousand dollars (\$800,000) and
11 promoting ongoing goodwill; and

12 WHEREAS, the New Mexico bass federation, the communities of
13 Truth or Consequences, Elephant Butte Dam and Williamsburg, the
14 county of Sierra and the state would stand to gain in many ways
15 by hosting an annual bassmasters invitational tournament at
16 Elephant Butte reservoir;

17 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE
18 OF NEW MEXICO that the state, Sierra county and the communities
19 of Truth or Consequences, Elephant Butte Dam and Williamsburg be
20 encouraged to invite B. A. S. S. to consider including Elephant
21 Butte reservoir on their western division invitational
22 tournament trail; and

23 BE IT FURTHER RESOLVED that these parties be encouraged to
24 work together to seek to sponsor a bassmaster invitational
25 tournament at Elephant Butte reservoir in the spring of 1998 and
