A JOINT RESOLUTION

APPROVING AND RATIFYING THE TRANSFER OF REAL PROPERTY BY THE
GENERAL SERVICES DEPARTMENT TO THE NEW MEXICO REGION NO. 2
HOUSING AUTHORITY.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

WHEREAS, the property control division of the general
services department has control over certain state buildings and
lands; and

WHEREAS, the property control division of the general
services department has authority to sell or trade state
buildings and real property under its control in accordance with
Section 13-6-3 NMSA 1978; and

WHEREAS, the property of approximately ten acres in the
area of the Las Vegas medical center is under the jurisdiction
of the property control division of the general services

2 WHEREAS, the state of New Mexico may enter into an
3 agreement with the region no. 2 housing authority to develop
4 housing for low income and disabled individuals in Las Vegas,
5 New Mexico; and

6 WHEREAS, the region no. 2 housing authority needs real
7 property in order to construct and develop housing for low-
8 income and disabled individuals; and

9 WHEREAS, the Las Vegas medical center supports the
10 community placement of the mentally disabled, and the region no.
11 2 housing authority agrees to designate one-half of the rental
12 units to accommodate people with disabilities;

13 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
14 STATE OF NEW MEXICO that the general services department is
15 authorized to transfer to the region no. 2 housing authority
16 approximately ten acres in Las Vegas, New Mexico; and

17 BE IT FURTHER RESOLVED that the secretary of general
18 services is empowered hereby to take all actions necessary to
19 accomplish the transfer of the real property to the region no. 2
20 housing authority; and

21 BE IT FURTHER RESOLVED that, pursuant to Section 13-6-3
22 NMSA 1978, this resolution fulfills all approval and
23 ratification prerequisites for the transfer of real property by
24 the general services department to the region no. 2 housing
25 authority; and
