16	Section 1. It is proposed to amend Article 20 of the

19	of the state of New Mexico. This section is intended to					
20	preserve, protect and strengthen the Spanish language and not to					
21	supersede any of the rights guaranteed to the people by this					
22	constitution.					
23	B. Spanish is the official language of the state of

25	C. The legislature shall enforce this section by

The legislature and officials of the state of New Mexico shall take all steps necessary to ensure that the role of Spanish as the common language of the state of New Mexico is preserved and enhanced. The legislature shall make no law that diminishes or ignores the role of Spanish as the common language of the state of New Mexico.

D. Any person who is a resident or who is doing business in the state of New Mexico shall have standing to sue the state of New Mexico to enforce this section, and the district courts shall have jurisdiction to hear cases brought to enforce this section. The legislature may provide for reasonable and appropriate limitations on the time and manner of suits brought under this section. "

Section 2. The amendment proposed by this resolution shall be submitted to the people for their approval or rejection at the next general election or at any special election prior to that date which may be called for that purpose.
