AN ACT

MAKING APPROPRIATIONS FOR CERTAIN STATE AGENCY PROJECTS AND
PROGRAMS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Four million dollars
(\$4,000,000) is appropriated from the subsequent injury fund to
the development training fund for expenditure in fiscal year
1997 for the purpose of paying for in-plant development training
programs conducted pursuant to the provisions of Section 21-19-7
NMSA 1978. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1997 shall not revert to the subsequent
injury fund.

Section 2. APPROPRIATION. -- Two million five hundred
thousand dollars (\$2,500,000) is appropriated from the general

1 fund to the corrections department for expenditure in fiscal
2 year 1997 for the purpose of paying for the operational expenses
3 of that department. Any unexpended or unencumbered balance
4 remaining at the end of fiscal year 1997 shall revert to the
5 general fund.

6 Section 3. APPROPRIATION.--Three million dollars
7 (\$3,000,000) is appropriated from the general fund to the human
8 services department for expenditure in fiscal year 1997 for the
9 purpose of providing medicaid payments. Any unexpended or
10 unencumbered balance remaining at the end of fiscal year 1997
11 shall revert to the general fund.

12 Section 4. APPROPRIATION.--Five hundred thousand dollars
13 (\$500,000) is appropriated from the general fund to the property
14 control division of the general services department for
15 expenditure in fiscal year 1997 for the purpose of paying for
16 utility and maintenance costs at Fort Stanton hospital. Any
17 unexpended or unencumbered balance remaining at the end of
18 fiscal year 1997 shall revert to the general fund.

19 Section 5. APPROPRIATION.--One million three hundred
20 thousand dollars (\$1,300,000) is appropriated from the general
21 fund to the taxation and revenue department for expenditure in
22 fiscal year 1997 for the purpose of making payments to the
23 information systems division of the general services department
24 for expenses incurred for use of the ONGARD system. Any
25 unexpended or unencumbered balance remaining at the end of

1 fiscal year 1997 shall revert to the general fund.

3 Section 6. APPROPRIATION.--One hundred thousand dollars
4 (\$100,000) is appropriated from the general fund to the office
5 of the governor for expenditure in fiscal year 1997 for the
6 purpose of implementing the provisions of Laws 1996, Chapter 44
7 creating and providing for the office on information and
8 communication management, the chief information officer and the
9 technical advisory committee. Any unexpended or unencumbered
10 balance remaining at the end of fiscal year 1997 shall revert to
11 the general fund.

12 Section 7. EMERGENCY.--It is necessary for the public
13 peace, health and safety that this act take effect immediately.
