AN ACT

RELATING TO CORRECTIONAL INSTITUTIONS; AMENDING SECTION 33-3-11
NMSA 1978 (BEING LAWS 1889, CHAPTER 9, SECTION 1, AS AMENDED) TO
CHANGE THE RATE AT WHICH MONETARY REDUCTIONS IN FINES OR COSTS
ARE COMPUTED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 33-3-11 NMSA 1978 (being Laws 1889,
Chapter 9, Section 1, as amended) is amended to read:

"33-3-11. JAIL FOR NONPAYMENT OF FINE. --

A. Whenever any person is committed to prison for
nonpayment of any fine or costs or both, he shall be credited
with [~~five dollars (\$5.00) a day in~~] a monetary reduction
thereof for each day or portion of a day of imprisonment. This
reduction shall be the current minimum wage per hour multiplied
by eight hours. When the person has remained imprisoned a
