RELATING TO CAPITAL EXPENDITURES; CHANGING THE PURPOSE OF A GENERAL FUND APPROPRIATION TO THE STATE DEPARTMENT OF PUBLIC EDUCATION FOR IMPROVEMENTS AT JACKSON MIDDLE SCHOOL IN BERNALILLO COUNTY; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. GENERAL FUND--STATE DEPARTMENT OF PUBLIC EDUCATION--CHANGE IN PURPOSE--APPROPRIATION.--The balance of the general fund appropriation made to the state department of public education pursuant to Subsection K of Section 33 of Chapter 222 of Laws 1995 for the purpose of refurbishing the cafeteria at Jackson middle school in Bernalillo county shall not be expended for its original purpose but is appropriated to the state department of public education to develop a student

Section 2. EMERGENCY. -- It is necessary for the public peace, health and safety that this act take effect immediately.
