RELATING TO VEHICLE REGISTRATION; PERMITTING VETERANS WHO ARE
BONA FIDE PURPLE HEART MEDAL RECIPIENTS TO RECEIVE TWO SPECIAL
REGISTRATION PLATES AT NO FEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 66-3-414 NMSA 1978 (being Laws 1987,
Chapter 23, Section 1, as amended) is amended to read:

"66-3-414. SPECIAL REGISTRATION PLATES FOR PURPLE HEART
VETERANS. --

A. The division shall issue special registration
plates for up to two vehicles to any person who is a veteran and
a bona fide purple heart medal recipient and who submits proof
satisfactory to the division that he has been awarded that
medal. No fee, including the regular registration fee
applicable to the passenger motor vehicle, if any, shall be

2 pursuant to this section. ~~[Any]~~ A person who is eligible for
3 [a] special registration [plate] plates pursuant to this section
4 and also eligible for one or more special registration plates
5 pursuant to Sections 66-3-406, 66-3-409, 66-3-411 and 66-3-412
6 NMSA 1978 shall be issued special registration plates pursuant
7 to only one [special registration plate of his choice] of those
8 sections, the choice of which shall be made by the veteran

9 B. No person shall falsely represent himself to be a
10 purple heart veteran so as to be eligible to be issued special
11 plates pursuant to this section when he in fact is not a purple
12 heart veteran.

13 C. Any person who violates the provisions of
14 Subsection B of this section is guilty of a misdemeanor. "
