AN ACT

RELATING TO LAW ENFORCEMENT; AMENDING A SECTION OF THE NMSA 1978
TO INCLUDE CONSERVATION OFFICERS OF THE DEPARTMENT OF GAME AND
FISH IN THE DEFINITION OF PEACE OFFICER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 29-4A-3 NMSA 1978 (being Laws 1995,
Chapter 59, Section 3) is amended to read:

"29-4A-3. DEFINITIONS. --As used in the Peace Officers'
Survivors Supplemental Benefits Act:

A. "fund" means the peace officers' survivors fund;

B. "peace officer" means any full-time salaried and
commissioned or certified law enforcement officer of a police or
sheriff's department or a conservation officer of the department
of game and fish as used in Chapter 17 NMSA 1978 that is part of
or administered by the state or any political subdivision of the
