A MEMORIAL

REQUESTING THAT THE STATE HIGHWAY AND TRANSPORTATION DEPARTMENT RESPECT TRADITIONAL RURAL COMMUNITIES, ARCHAEOLOGICAL SITES AND ENVIRONMENTAL VALUES AND INVOLVE LOCAL COMMUNITIES DURING RECONSTRUCTION OF STATE HIGHWAY 14.

WHEREAS, state highway 14 is a scenically valuable roadway between Santa Fe and Cedar Crest, attracting significant tourist dollars to communities along the route; and

WHEREAS, the highway corridor traverses several traditional communities designated by Santa Fe county; and

WHEREAS, there are many archaeological sites also along the route; and

WHEREAS, these environmental, historic, prehistoric and culturally valued communities and sites may be damaged by construction of improvements to highway 14;
