A JOINT RESOLUTION

PROPOSING AN AMENDMENT TO ARTICLE 6, SECTION 36 OF THE CONSTITUTION OF NEW MEXICO TO REQUIRE THAT PERSONS APPLYING FOR NOMINATION OR BEING NOMINATED FOR THE OFFICE OF DISTRICT JUDGE BE RESIDENTS OF THE JUDICIAL DISTRICT IN WHICH THE OFFICE IS SITUATED.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. It is proposed to amend Article 6, Section 36 of the constitution of New Mexico to read:

"There is created the "district court judges nominating committee" for each judicial district. Each and every provision of Section 35 of Article 6 of this constitution shall apply to the "district court judges nominating committee" except that: the chief judge of the district court of that judicial district or the chief judge's designee from that district court shall sit

on the committee; there shall be only one appointment from the
court of appeals; and the citizen members and state bar members
shall be persons who reside in that judicial district. An
applicant to the district judges nominating committee shall be
at the time of filing the application a resident of the judicial
district in which he seeks appointment."

Section 2. The amendment proposed by this resolution shall be submitted to the people for their approval or rejection at the next general election or at any special election prior to that date which may be called for that purpose.
