1 ISSUED--APPROPRIATION OF PROCEEDS.--The state board of finance 2 may issue and sell severance tax bonds in compliance with the Severance Tax Bonding Act in an amount not exceeding five 3 4 million eight hundred thousand dollars (\$5,800,000) when the department of public safety certifies the need for the 5 issuance of the bonds. The state board of finance shall 6 7 schedule the issuance and sale of the bonds in the most 8 expeditious and economical manner possible upon a finding by 9 the board that the project has been developed sufficiently to 10 justify the issuance and that the project can proceed to 11 contract within a reasonable time. The state board of finance 12 shall further take the appropriate steps necessary to comply 13 with the Internal Revenue Code of 1986, as amended. The 14 proceeds from the sale of the bonds are appropriated to the department of public safety for the purpose of equipping forty 15 16 additional state police officers each fiscal year during 17 fiscal years 2000 through 2002. Any unexpended or 18 unencumbered balance remaining at the end of fiscal year 2002 19 shall revert to the severance tax bonding fund. If the 20 department of public safety has not certified the need for the issuance of the bonds by the end of fiscal year 2001, the 21 22 authorization provided in this section shall be void.




