BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Four million four hundred thousand dollars (\$4,400,000) is appropriated from the general fund to the gaming control board for expenditure in fiscal year 1999 in the following amounts and for the following purposes:

- $\qquad \qquad (1) \quad \text{one million four hundred thousand dollars} \\ (\$1,400,000) \ \text{for operational expenses of the gaming control} \\ \text{board; and}$
- (2) three million dollars (\$3,000,000) for capital expenditures required to develop and implement a

system of continuous computer monitoring of licenced gaming machines mandated by the Gaming Control Act.

B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
