AN ACT

MAKING AN APPROPRIATION FOR A PROGRAM TO IDENTIFY RELEASED
FELONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Twenty thousand dollars
(\$20,000) is appropriated from the general fund to the
corrections department for expenditure in fiscal year 1999 for
the purpose of creating a pilot program to publicize the
identity of felons convicted of murder, rape, child
molestation and chronic repeat drunk driving when the felon is
released from prison. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.
