MAKING AN APPROPRIATION TO STUDY THE FEASIBILITY OF
ESTABLISHING COMMUNITY SENTENCING BOARDS IN NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Twenty thousand dollars (\$20,000) is appropriated from the general fund to the criminal and juvenile justice coordinating council for expenditure in fiscal year 1999 for the purpose of conducting a feasibility study regarding the establishment of community sentencing boards in New Mexico. The criminal and juvenile justice coordinating council shall gather information regarding the operation of existing community sentencing boards in New York City, Vermont, Austin, El Paso and the Canadian province of Saskatchewan and report its findings to the legislature no later than December 1, 1998. unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
