AN ACT

MAKING AN APPROPRIATION FOR REGIONAL WATER PLANNING FOR SANDOVAL, BERNALILLO, VALENCIA AND SOCORRO COUNTIES; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the interstate stream commission for expenditure in fiscal years 1998 and 1999 for the purpose of funding regional water studies in Sandoval, Bernalillo, Valencia and Socorro counties. The money appropriated shall be expended for a cost-sharing agreement with the United States army corps of engineers pursuant to its planning assistance to the state regional water planning program. The studies shall be to determine the water planning needs of the four counties; to

compile background information, map products and historical water use in each of the counties in accordance with the regional water planning handbook of the commission; and to provide necessary information to initiate a regional water plan pursuant to Sections 72-14-43 and 72-14-44 NMSA 1978. Work undertaken pursuant to this appropriation shall be planned and coordinated in advance with entities pursuing regional water planning by or on behalf of the counties. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
