BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred fifty thousand  
dollars (\$150,000) is appropriated from the general fund to  
the community college board of Santa Fe community college for  
expenditure in fiscal years 1998 and 1999 for the purpose of  
implementing a public schools initiative program. Any  
unexpended or unencumbered balance remaining at the end of  
fiscal year 1999 shall revert to the general fund.
