"16-2-7. RULES AND REGULATIONS.--The secretary shall promulgate and adopt rules and regulations for each park as circumstances may demand to the end that each park may be made as nearly self-supporting as possible; provided, however, that no fee shall be imposed for day use of a state park."

Section 2. APPROPRIATION.--Nine hundred twenty-six thousand dollars (\$926,000) is appropriated from the general fund to the state parks division of the energy, minerals and natural resources department for expenditure in fiscal year
